THE PROGRAM IS OFFERED TO RECENT COLLEGE GRADUATES AND COLLEGE SENIORS, FREE OF CHARGE, WITH THE GOAL OF BUILDING "HARD" SKILLS AS WELL AS "SOFT SKILLS" THROUGH A FORMAL CURRICULUM. THE PROGRAM COMBINES CLASSROOM INSTRUCTION WITH PROJECT-BASED WORKSHOPS MEANT TO DEVELOP REAL WORLD EXPERIENCE.
